

Terms and conditions of the "1000 CFA francs silver coin 'Black Swan' from the Lithuanian Mint" raffle

“1000 CFA francs silver coin ‘Black Swan’ from the Lithuanian Mint” - the World Money Fair raffle

1. Prize raffle "1000 CFA francs silver coin ‘Black Swan’ from the Lithuanian Mint " - the World Money Fair raffle

1.1 The raffle "1000 CFA francs silver coin ‘Black Swan’ from the Lithuanian Mint " - the World Money Fair raffle is organised by the World Money Fair Berlin GmbH, Ollenhauerstraße 97, 13403 Berlin.

1.2 The raffle will run from 20/03/2026 - 20/04/2026 (23:59).

1.3 Participation is voluntary and free. Participants (hereafter referred to as both male and female) are only responsible for the costs associated with participating via the Internet (Internet connection fee). Participation and chances of winning are independent of the purchase of goods or services.

1.4 The raffle is entered via the competition form on the www.worldmoneyfair.de website. By entering the raffle, the entrant accepts these terms and conditions.

2. Participation/procedure

2.1 Participation is possible via the competition form on the website www.worldmoneyfair.de and requires registration as a World Money Fair Club member.

2.2 The raffle is only open to World Money Fair Club members. All natural persons aged 18 or over who are members of the World Money Fair Club and who register via the registration form on the website www.worldmoneyfair.de are eligible to participate. Employees of World Money Fair Berlin GmbH are excluded from participation.

2.3 To enter the raffle, entrants must complete the entry form on the www.worldmoneyfair.de website.

2.4 You can enter as many times as you like. However, each entrant is only eligible to win once and will only be entered into the draw once.

2.5 Participation via competition services, automated mass participation procedures of third parties, agencies or other commercial providers is not permitted.

2.6 Participation is only allowed with one account. If it is suspected that a participant is using more than one account, the Organising Company reserves the right to proceed as described in section 2.7.

2.7 In the event of a breach of these terms and conditions, the Promoter reserves the right to disqualify the entrant from the raffle. In such cases, prizes may be subsequently withdrawn and reclaimed.

2.8 By participating in the raffle, the participant agrees that his/her name may be published on the website www.worldmoneyfair.de and/or in the World Money Fair Club newsletter if he/she is one of the winners.

3. Determination of winners

3.1 Two winners will be selected from all participants who have registered on 21/04/2026. Each entrant will only be entered into the draw once. Prizes will be awarded at random.

3.2 The two winners will be drawn by the staff of the World Money Fair and contacted by e-mail.

4. Prize

4.1 Each of the two winners will receive one "1000 CFA francs silver coin 'Black Swan' from the Lithuanian Mint"

4.2 The Promoter reserves the right to award further prizes as an incentive to participants.

4.3 The prize cannot be paid in cash or substituted. Prize entitlement is non-transferable.

5. Data protection/consent to use of personal data

5.1 In exchange for the opportunity to participate in the raffle, the entrant agrees that the photo may reveal information about the entrant's ethnic origin, political opinions, religious or philosophical beliefs or health (e.g. skin colour, headgear, glasses). His or her consent also applies to this information. The Participant acknowledges that information on the Internet is accessible worldwide, can be found using search engines and can be linked to other information from which it may be possible to create personality profiles about him/her. The Participant is aware that information posted on the Internet, including photographs, can be easily copied and redistributed and that there are specialised archiving services that aim to permanently document the status of certain websites at certain dates. This may mean that information posted on the Internet may be found elsewhere even after it has been deleted from the original site.

5.2 Consent is also given in exchange for the opportunity to participate in the raffle with the knowledge that the Participant is aware that photos and/or videos in which he/she can be

recognised may also be published on social media (such as Facebook or Instagram) together with his/her first name. The Participant is aware that, according to the information currently available, photos, videos and other data on social media cannot be deleted, but can only be made inaccessible to the public. There is currently insufficient information about the internal use of photos, videos and other data by social media operators, for example to create personality profiles. Social media are generally operated by US providers. Participants are aware that personal data relating to them may be transferred to a third country, i.e. a country outside the European Union and the European Economic Area or a country that does not provide an adequate level of data protection. If the data is transferred to the USA, for example, there is a risk that my data may be processed by the US authorities for monitoring and surveillance purposes, without me being able to seek redress.

6. Liability

6.1 All information provided by the World Money Fair Berlin GmbH, in particular in connection with the publication of the names of winners etc., is provided without any guarantee as to the accuracy or completeness of the information provided, as this is provided by the participants.

6.2 If a winner has any claims in connection with the prizes received, these must be made directly to the manufacturer/retailer, supplier, tour operator or other service provider, insofar as this is legally permissible. If such claims are made against the Organiser, they will be assigned to the respective winners.

6.3 World Money Fair Berlin GmbH is not liable for damages that may occur during participation in the competition as a result of errors, delays or interruptions in transmission, malfunctions or deletion of data, viruses or in any other way, unless such damages are caused intentionally or by gross negligence on the part of World Money Fair Berlin GmbH. Liability for culpable injury to life, body or health remains unaffected.

7. Miscellaneous

7.1 The law of the Federal Republic of Germany applies.

7.2 The Promoter may alter, suspend or terminate the Competition at any time if circumstances beyond the control of the Promoter make this necessary or if such action is the only way to ensure the proper conduct of the Competition.

Legal recourse is excluded.
